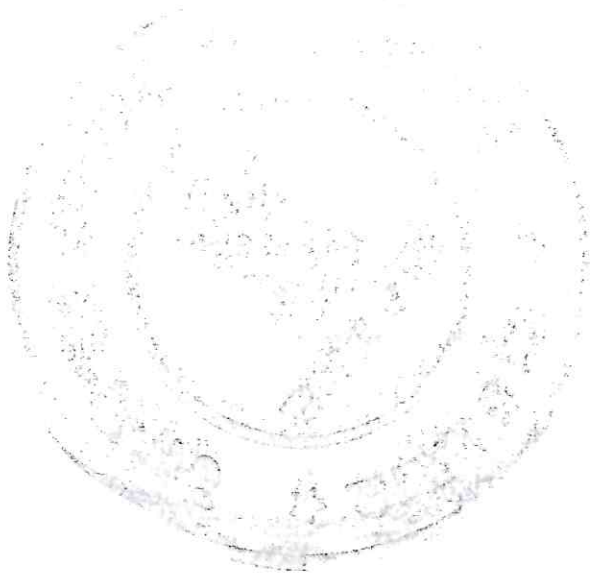

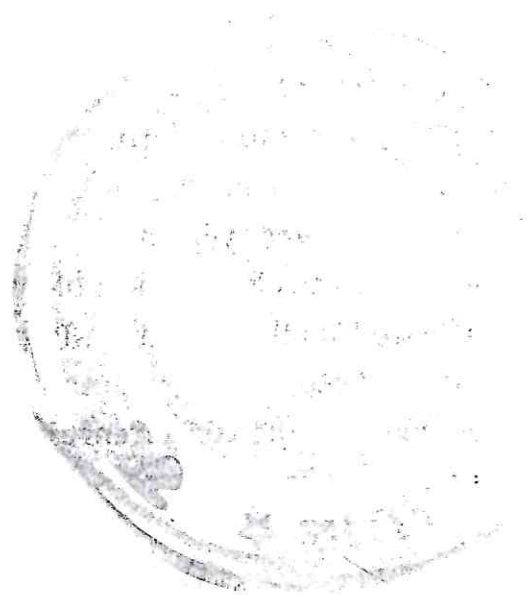
POWERS AND FUNCTIONS OF TRUSTEES :

- (i) The Trustees shall be at liberty and will have discretion to accept property movable or immovable, etc from any person for the advancement of the objectives of the Trust.

- (iv) The Chief Trustee will appoint regular/permanent, part time paid or honorary staff if necessary according to the need of the Trust and use the Trust fund for payment of their salaries, compensations or expenses.
- (v) The Trustees shall have power to frame rules and regulations to carry out and to give effects to the objects and the purposes of the Trust and or managing the affairs of the Trust and to remove, alter, add or amend the same from time to time.
- (vi) It will be lawful for the Trustees to delegate any of their powers of management.

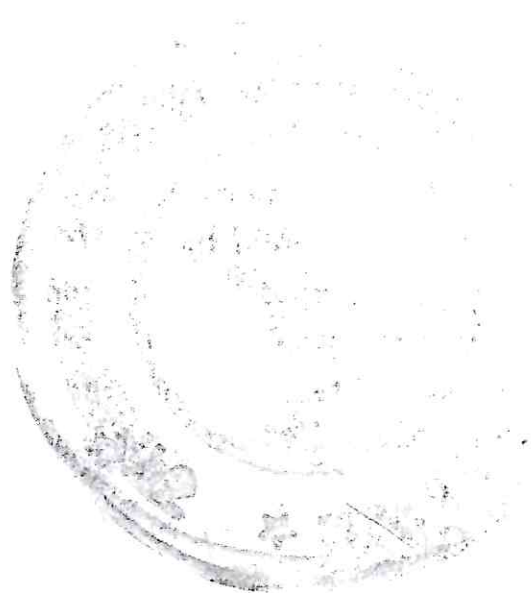

DUTIES AND OBLIGATIONS OF THE TRUSTEES:

- (i) The Chief Trustee will be having administrative control over all functions of the Trust,
- (ii) The Co-Trustee will be having financial control over income & expenditure of the Trust and without his consent no financial transaction would be done of the Trust,
- (iii) The Trustees will manage the subject matter of the Trust and take decisions regarding the matter of policies concerning the fulfillment of its objects as the majority of Trustees may decide.
- (iv) The Trustees shall out of the income of the Trust in the first instance pay all management charges, cost, expenses and salaries, etc. and other expenses incidental to the management and the administration of the Trust, its properties and assets and shall utilize the net income for the charitable objects aforesaid in the best possible manner in accordance with the objects of the Trust with the concurrence of managing Trustee.
- (v) The Trustees shall mention a true and correct account of the fund and faithful record of their deliberations.
- (vi) The Trustees shall not be entitled to any remuneration for the services rendered by them as such with the concurrence of the managing Trustee.
- (vii) The Trustees shall be respectively answerable only for such money or securities or other property as they shall respectively actually receive notwithstanding their signing any receipt for the sake of confirming it or advance receipt and shall respectively be answerable and accountable only for their own respective acts receipts, omissions, neglects and defaults and not for those of each other or for any banker, broker, auctioneer, or other persons with whom or into whose


The Trustees shall have power to keep invests the Trusts funds in suitable avenues keeping in view the safety of the investments including movable and immovable properties, shares, deposits in bank, debentures, govt. securities and loans, stocks deposit with post office and other govt. institutions provided always that the Trustees shall have power to sell, convert, vary the said investment into investments of the same or other nature authorized by these presents of resale, convert or realize the investment or investments into money.

- (viii) The Chief Trustee shall appoint auditor who shall have assess to all books, vouchers, accounts and documents connected with the Trust and who shall duly audit the receipts and payments from the fund, the Trust and who shall duly audit the receipts and payments from the fund, the incomes accruing to the Trust, the outgoings and expenses and submit on audit report.









- (ix) The Trust shall be irrevocable same as provided in this Trust or in the applicable law.

NUMBERS OF TRUSTEES:

- (i) The number shall not be less than two provided that notwithstanding anything here in contained any act done bonfires by the surviving or continuing Trustee or Trustees in the usual courses of the administration of the Trust and which is otherwise authorized under these presents and shall not be invalid by reasons of requisite number of Trustees without the concurrence of Managing Trustee.
- (ii) In case of differences of opinion arising among the Trustees and in all matters wherein the Trustees have discretionary power the vote of the majority of the Trustees for the time being shall prevail with the concurrence of Managing Trustees and be binding on the minority as well as on those Trustee who may not have remained present or voted. In case the Trustees are equally divided in opinion the matter shall be decided according to the casting vote of the Managing Trustee.
- (iii) The board of Trustees shall meet as often as necessary.
- (iv) The meetings of the Trustees shall be convened at such place in India and at such date as may be agreed upon by the Trustees or at fixed by the Managing Trustees.
- (v) At least the Trustees, present, within half an hour of the time fixed for the meeting shall form quorum. If no quorum is present ever after expiry of half an hour the meeting shall stand adjourned and to such date, hour and place as may be fixed when the meeting has been adjourned for want of quorum not withstanding anything started above the Trustees present shall constitute forum for the next meeting.

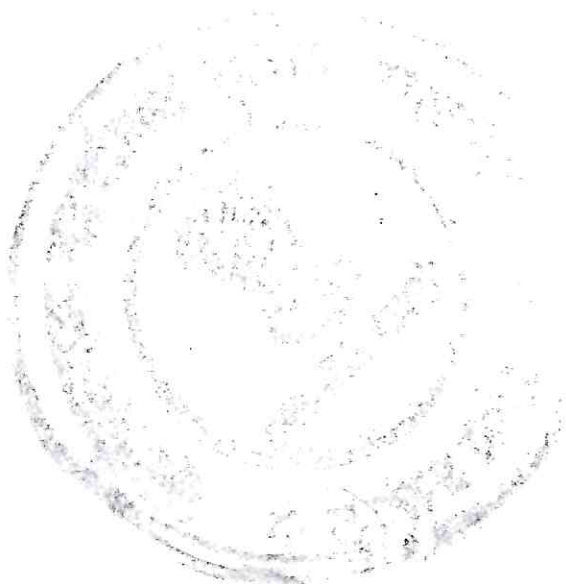

OFFICE:

TERMINATION OF OFFICE OF THE TRUSTEES:

(a) Trustees shall cease to hold office.

(i) If he dies.

(ii) If he resigns.

(iii) If he is adjudged insolvent or found guilty of an offence involving moral turpitude.

(iv) If he is found to have acted against the interest of the Trust.

(v) If it is unanimously decided by the Trustees specified aforesaid clause above that his continuation in the office is against the interest of the Trust.

(vi) Upon expiry of the period up to which the Board of Trustees have nominated the Trustee.

(b) That on the death of any Trustee ,only their legal heirs or family members would be entitled to become a Trustee of the Trust with the consent of remaining /another Trustee and further no outsider would be entitled to become a Trustee.

(c) The term of the founder Trustees would be five (5) years from the registration of the Trust and further the founder Trustees will decide the future trustees;

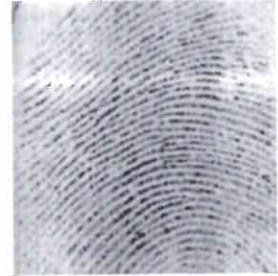

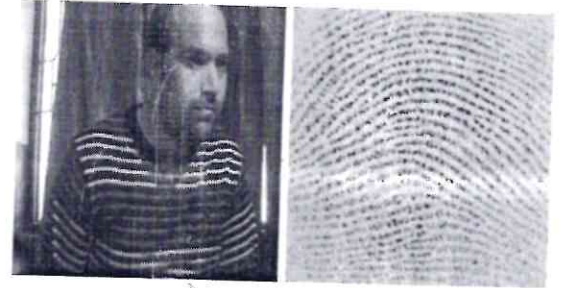

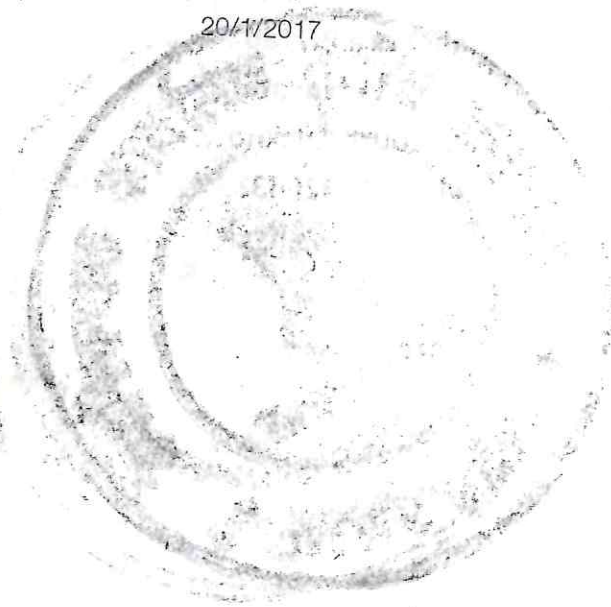
